1. BENCHMARK - TOP STEM OF EXISTING FIRE HYDRANT LOCATED IN FRONT OF SUBLOT No. 36, ELEVATION = 712.24.

2. CONCRETE SIDEWALK TO FIVE FEET WIDE AND FOUR INCHES THICK. SIDEWALK TO BE SIX INCHES THICK AT DRIVEWAY APRON.

3. ALL DOWNSPOUTS TO BE OUTLETTED TO SPLASH BLOCKS. 4. SUMP PUMP REQUIRED FOR BASEMENT.

5. CONTRACTOR RESPONSIBLE FOR CONTACTING THE OHIO UTILITY PROTECTION SERVICE (1.800.362.2764) AND ALL UTILITY COMPANIES A MINIMUM OF 48 HOURS PRIOR TO CONSTRUCTION.

6. THE LOCATION BOTH HORIZONTAL AND VERTICAL OF EXISTING UNDERGROUND UTILITIES SHOWN HEREON, HAVE BEEN OBTAINED BY A DILIGENT AND COMPREHENSIVE SEARCH OF AVAILABLE RECORDS.
