

Construction Entrance Detail




GENERAL NOTES:

- 1. BENCHMARK EXISTING HYDRANT, TOP FLANGE ELEVATION = 927.29
- 2. DRIVEWAY APRON TO BE 6" THICK CONCRETE.
- 3. ALL DOWN SPOUTS TO BE OUTLETTED TO SPLASH BLOCKS.
- 4. CONTRACTOR RESPONSIBLE FOR CONTACTING THE OHIO UTILITY PROTECTION SERVICE 1 (800) 362-2764 AND ALL UTILITY COMPANIES A MINIMUM OF 48 HOURS PRIOR TO CONSTRUCTION.
