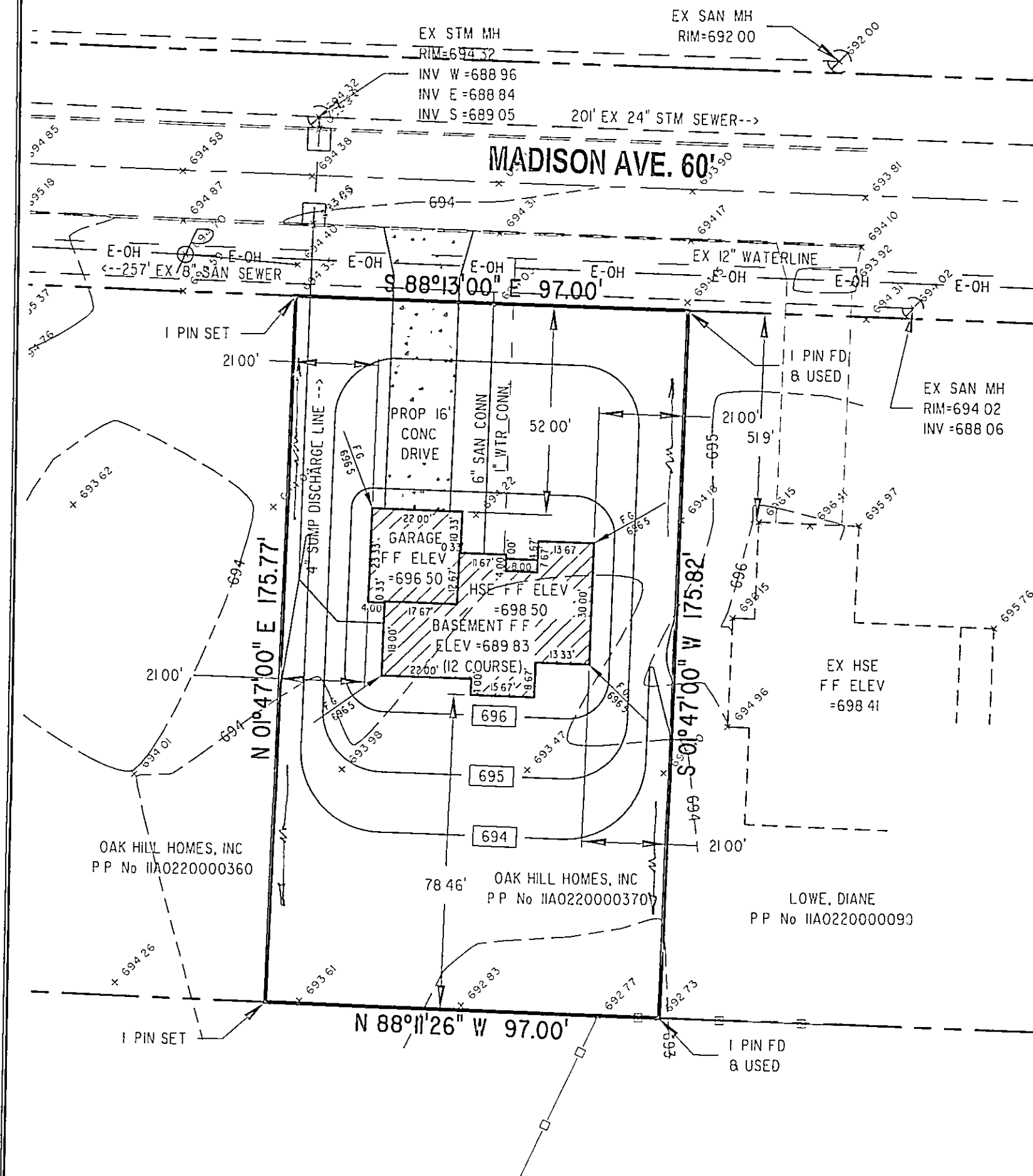

1. BENCHMARK - TOP STEM OF EXISTING FIRE HYDRANT LOCATED APPROX. 172± EAST OF SUBLOT 37, ELEVATION = 695.95.
2. DRIVEWAY APRON TO BE 6" THICK CONCRETE.
3. ALL DOWNSPOUTS TO BE OUTLETED TO SPLASH BLOCKS

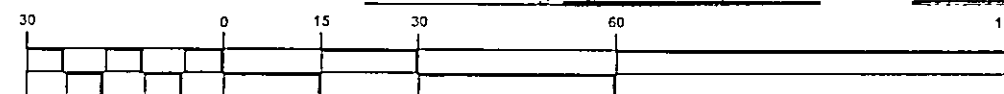

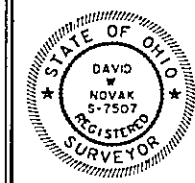
