Powers to The Pittsburgh, Painesville and Fairport Hailway Co. in Volume 77, Page 442 LODR (9/26/1899) transfers the same property as prior deed and describes a "Right of Way" of 50 wide (25 feet each side of the tracks that shall terminate and revert to the owners if not operating as a railroad.
