ITEM 614 - MAINTAINING TRAFFIC

GENERALLY THE CONTRACTOR SHALL CONDUCT HIS OPERATIONS AS TO MAKE THE PROPOSED REPAIR WITH A MINIMUM OF HAZARD DELAY AND INCONVENIENCE TO THE MOTORISTS USING THE HIGHWAY AFFECTED BY THE WORK DONE UNDER THIS CONTRACT: FUTHERMORE, IN ADDITION TO THE CONSTRUCTION AND MATERIAL SPECIFICATIONS, THE FOLLOWING SPECIFIC PROVISIONS ARE MANDATORY.

I. NOTIFICATION

SINCE FUNCTIONAL TRAFFIC CONTROL IS A MAJOR CONCERN ON THIS PROJECT, IT IS ESSENTIAL THAT THE MOTORING PUBLIC BE ADEQUATELY FOREWARNED OF FUTURE LANE CLOSURES AND TRAFFIC CONSTRICIONS. THEREFORE, THE CONTRACTOR SHALL SUBMIT A WRITTEN SCHEDULE TO THE ENGINEER, RESPONSIBLE LAW ENFORCEMENT AGENCIES, AND THE ODOT PUBLIC INFORMATION OFFICE (216-581-2333 EXT 244) INDICATING THE LOCATIONS AND DATES OF THE LANE CLOSURES AT LEAST 3 DAYS PRIOR TO THE IMPLEMENTATION OF ANY SUCH CLOSURES.

II. PART 1: NIGHTTIME WORK (THE HOURS FROM SUNSET TO SUNRISE

9:00 PM - 6:00 AM)

THE CONTRACTOR IS NOT PERMITTED TO WORK AT NIGHT.

II. PART 2 & 3: IR-90 MAINTENANCE OF TRAFFIC

DURING CONSTRUCTION, WHENEVER A TRAVELED LANE ON IR-90 NEEDS TO BE CLOSED AS DETERMINED BY THE ENGINEER, SHORT DURATION TRAFFIC CONTROL AS SHOWN ON STANDARD DRAWING MT 95.30M SHALL BE USED.

ALL LANE CLOSURES ON IR-90 MAY ONLY BE IMPLEMENTED AT THE TIMES PERMITTED BY THE "DISTRICT 12, PERMITTED LANE CLOSURE TIMES" LIST, WHICH IS LOCATED ON THE ODOT WEB SITE:

THE LATEST REVISION, AT 14 DAYS PRIOR TO THE BID DATE, SHALL BE IN EFFECT FOR THIS PROJECT.

NO LANE OR SHOULDER CLOSURES SHALL BE IN PLACE WHEN NO WORK IS BEING PERFORMED.

III. RESTRICTIONS

1. ALL CLOSURES SHALL BE IN ACCORDANCE WITH THE APPLICABLE STANDARD CONSTRUCTION DRAWING(S).
2. NO LANE CLOSURES SHALL BE IMPLEMENTED OR IN PLACE ON WEEKDAYS DURING THE HOURS OF 6:00 AM TO 9:00 AND THE HOURS OF 4:00 PM TO 7:00 PM.
3. ALL THROUGH TRAFFIC LANES SHALL BE KEPT OPEN AT ALL TIMES EXCEPT DURING HOURS OF CONSTRUCTION.
4. PEDESTRIAN TRAFFIC SHALL BE PERMITTED ON AT LEAST ONE SIDE AT ALL TIMES.

NOTWITHSTANDING THE ABOVE, NO LANE CLOSURES SHALL OCCUR DURING THE PERIOD BEGINNING AT 12:00 NOON ON THE DAY PRECEDING AND CONTINUING UNTIL NOON ON THE DAY FOLLOWING LEGAL HOLIDAYS AND HOLIDAY WEEKENDS SUCH AS MEMORIAL DAY, FOURTH OF JULY, AND LABOR DAY. FURTHERMORE, NO LANE CLOSURES SHALL BE IMPLEMENTED OR IN PLACE DURING INCREASED TRAFFIC VOLUMES CAUSED BY SPECIAL EVENTS OR WHEN THE ENGINEER DEEMS THE CLIMATOLOGICAL CONDITIONS TOO HAZARDOUS.

IV. MAINTENANCE OF TRAFFIC MATERIALS

A. SIGNS

SIGN DIMENSIONS AND SPECIFICATIONS, INCLUDING LETTER SIZES SHALL BE AS PROVIDED IN THE "MANUAL", OR IN DESIGN DRAWINGS PROVIDED BY THE DEPARTMENT OF TRANSPORTATION. THE SIGNS SHALL BE SUBJECT TO APPROVAL OF THE ENGINEER PRIOR TO THE START OF THE PROJECT.

B. SIGN SUPPORTS

SIGN SUPPORTS SHALL BE OF SUFFICIENT SIZE AND MASS AS TO FIRMLY SUPPORT THE SIGNS AT THE APPROPRIATE HEIGHT. SUPPORTS SHALL BE AS SHOWN ON THE STANDARD DRAWINGS.

C. CONES

CONES SHALL BE LOCATED AS SHOWN IN THE "MANUAL" AND THE STANDARD DRAWINGS.

V. PAYMENT

PAYMENT FOR PROVIDING, ERECTING, MAINTAINING AND REMOVING TEMPORARY MAINTENANCE OF TRAFFIC CONTROL DEVICES SHALL BE MADE UNDER THE LUMP SUM PRICE BID FOR ITEM 614-MAINTAINING TRAFFIC.
