Plat of Survey, No. 162, Painesville Town 11, Range 8

Survey made May 26th 1891, at the request of S. R. House
For the purpose of Making an addition of Lots to the Village of Painesville

by H. S. Munson County Surveyor.

DESCRIPTION.

Addition of Lots to the Village of Painesville by S. R. House comprising all the following land in Lot No 12 Tract No 4 and bounded as follows. Beginning at a stake in the easterly line of Newell Street in the South line of said Lot No. 12. Thence with said line of Newell Street N. 15 1/2° W. 3 chains + 75 links to a stake in south line of Eagle Street, thence with the South line of Eagle Street East 11 chains + 73 links to a stake at the angle of said Street, thence with south line of Eagle Street S. 62 3/4° E. 9 chains + 60 links to the South line of said Lot No. 12, thence with said Lot line N. 87 3/4° W. 19 chains and 28 links to the place of beginning. Containing 6 7/100 acres of land.

It is proposed to hereby dedicate three strips of land each 40 feet wide, being at right angles to Eagle Street and extending from Eagle Street to the South line of said Lot No. 12 as are shown on the Plat as A, B, & C Streets. Distances on the Plat are given in feet + 10^{ths} of feet. Bearings of said streets are given on the lines of said streets. Numbers of Lots are given in Red figures near their respective centers. Scale 50 feet to one inch.

(I) hereby accept this plat & dedicate said three streets of land each 40 feet wide, for streets running from Eagle Street and right angle streets to the South line of said Lot No. 12
