Plat of Survey (Horace Rice Est.) No. 68, Mentor Township 10, Range 9

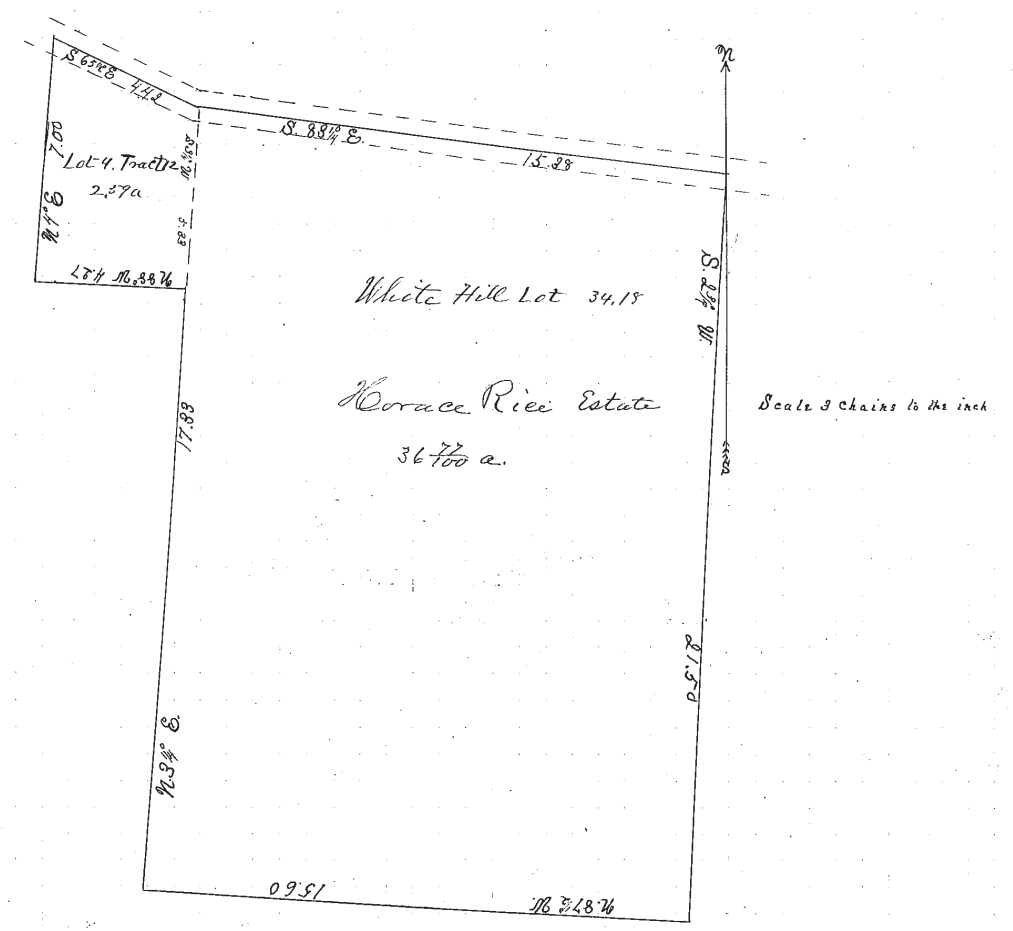

DESCRIPTION.

Being the South West part of White Hill Lot, + South East part of Lot No 4 in Tract No. 12 in Mentor Township, bounded as follows
 Beginning in the center of the Black Brook road, at the North West corner of W. Harvey's land, thence with the west line of said land S. 23 3/4° W 21 chains + 50 links to the south line of said lot, thence with said line N. 87 1/2° W, 15 chains + 60 links to the East line of Tract No. 12, thence with said line N. 3/4° E, 17 chains + 33 links to the S. E. corner of said Lot No 4, thence with the south line thereof N. 88° W, 4 chains + 27 links to the South East corner of Fred Williams land, thence with said land N. 4° E, 7 chains to the center of said road, thence with the road S. 65 1/2° E, 4 chains + 42 links to the west line of White Hill Lot, thence S. 83 1/4° E, 15 chains + 38 links to the place of beginning, containing 36 7/10 a (34.18 acres in White Hill Lot, + 2.59 acres in Lot No. 4 of Tract 12.
