

W. J. CARMICHAEL

W. J. Carmichael, Mayor of Willoughby, O., was born in Wellsburg, West Virginia, September 17, 1875, and is one of a family of six daughters and eight sons born to W. J. Carmichael and Mary Forbes Carmichael.

Mr. Carmichael was married to Daisy Lee Andrews of Des Moines, Iowa, and to them were born twin daughters, one of which became a victim to typhoid fever in an epidemic in the village in 1910.

Mr. Carmichael had just reached the voting age when he was chosen Clerk of the Council of Wellsburg; and there he received a training that has served him well in his services here. In 1911 he was elected to a position on the village Board of Public Affairs. As a member of that Board, he, in conjunction with the other members, (Ferd. Bollman and Wm. Gillespie) secured the approval of the citizens of Willoughby to build and equip a water filtration plant, which would provide pure water for the village. This, Mr. Carmichael considers is the most important act of his official life. Before his term expired as member of the Board of Public Affairs, he was elected Mayor, and was re-elected Mayor in the election of 1915, in one of the hottest political fights ever had in Willoughby by a majority of about three to one. Mr. Carmichael believes in honesty of purpose and because of this disposition and an inflexible desire to see the right prevail in matters under his stewardship he became a veritable "Thorn in the Flesh" of some persons whom he believed were using their positions for selfish purposes. Evidently the citizens of Willoughby were in sympathy with him as is attested by their vote as mentioned above.

Mayor Carmichael is most public spirited, and always contributes in time and money to public projects.

He is an active member of the Masons and Knights of Pythias organizations.

**Village Library and Historical Association
WILLOUGHBY OHIO**

The Willoughby Township and Village Library and Historical Association was incorporated April 5, 1906. It is housed in a beautiful brick building in a slightly location facing the Monument Park. On the main floor are reading, reference and children's rooms and book stacks. On the ground floor a small auditorium furnishes a meeting place for committees, clubs and other civic organizations. The building was the gift of Mr. Andrew Carnegie and cost \$14,500. The site cost \$5,750. The money for the site was raised by popular subscription.

Inscription on Historical Tablet on the New High School Building in Willoughby Village

This Tablet commemorates four institutions of learning previously occupying this site. The Willoughby Medical College, 1834 to 1846 Building remodeled and used by The Willoughby Female Seminary, 1847 until its destruction by fire in 1856 The Willoughby Collegiate Institute incorporated in 1859, existed until 1868. when the name was changed to The Willoughby College, which continued until 1882. The building was occupied jointly by the College and The Willoughby High School from 1876 to 1882 and subsequently by the High School, until it was razed in April, 1915 to make place for the present edifice.
