

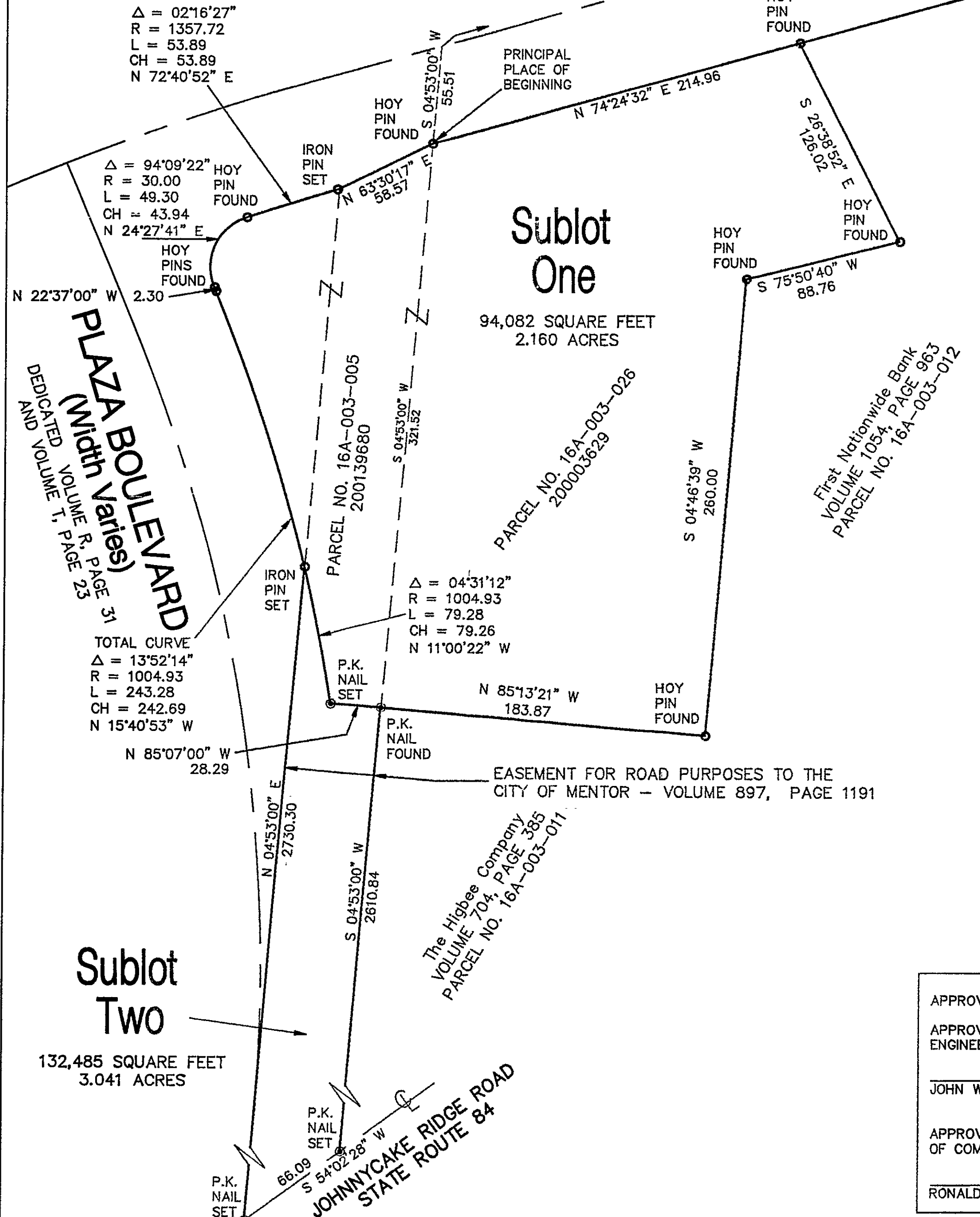
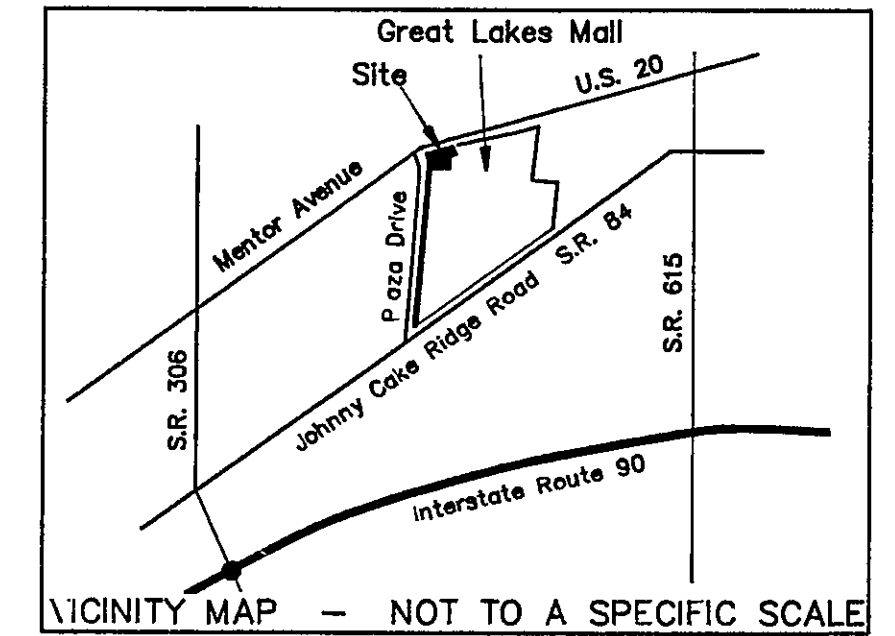

- The basis for the bearings used hereon is that of South 75°18'32" West along the centerline of Mentor Avenue from the deed recorded in Document No. 2000003628 of Lake County Records.
- The remainder of the Great Lakes Mall property was not included in this survey.
- Survey references used: ALTA Survey of Great Lakes Mall by John R. Hoy and Associates, Inc. dated September 11, 1993 and ALTA Survey of Great Lakes Mall Parcel No. 5 by John R. Hoy and Associates, Inc. dated November 02, 1999.

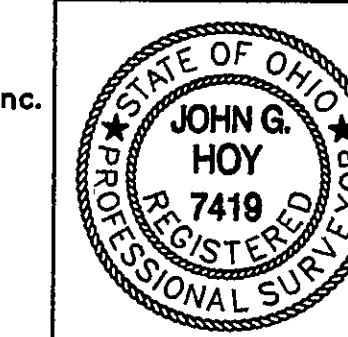
