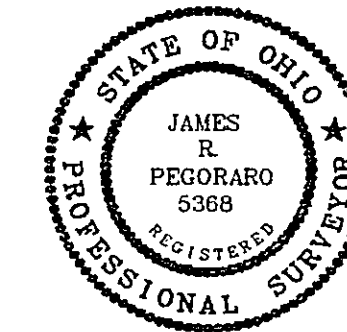


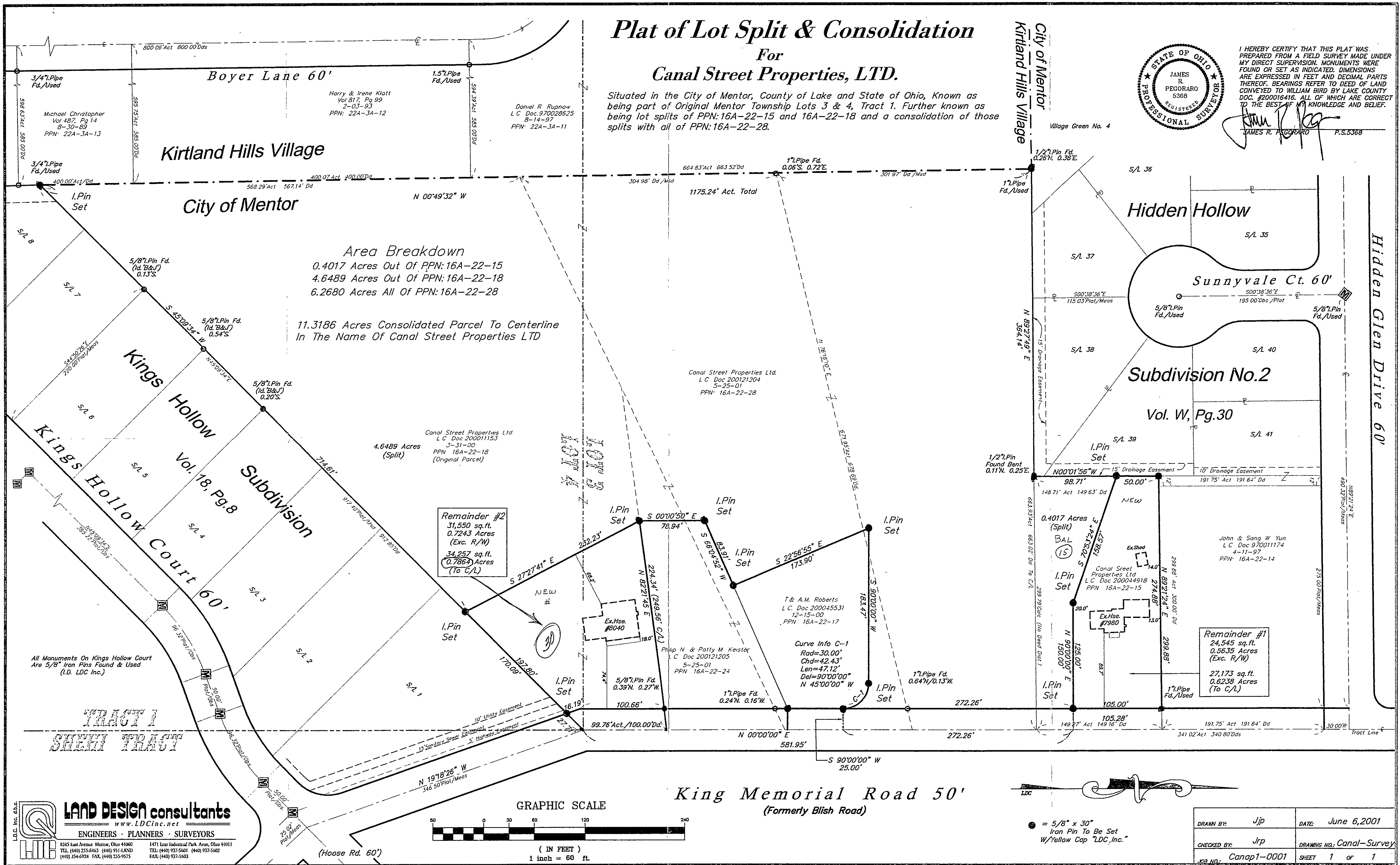
# Plat of Lot Split & Consolidation For Canal Street Properties, LTD.

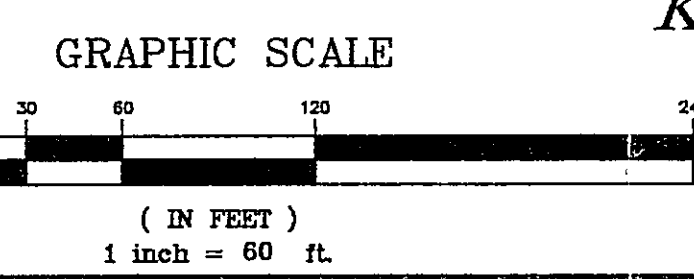
