


PLAT OF LOT CONSOLIDATION






BASIS OF BEARING

The Basis of Bearing for this survey is Grid North of the Ohio State Plane Coordinate System, North Zone (FIPS Zone 3401), on the North American Datum of 1983(2011) (Epoch 2010.000) using geoid model GEOID18, with a combined scale factor of 1.0003221927392. A GNSS Real Time Kinematic Network survey was used to establish a bearing of North 85°40'12\"/>
