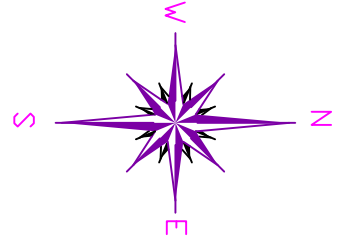


**LOT SPLIT & COMBINATION OF LANDS**

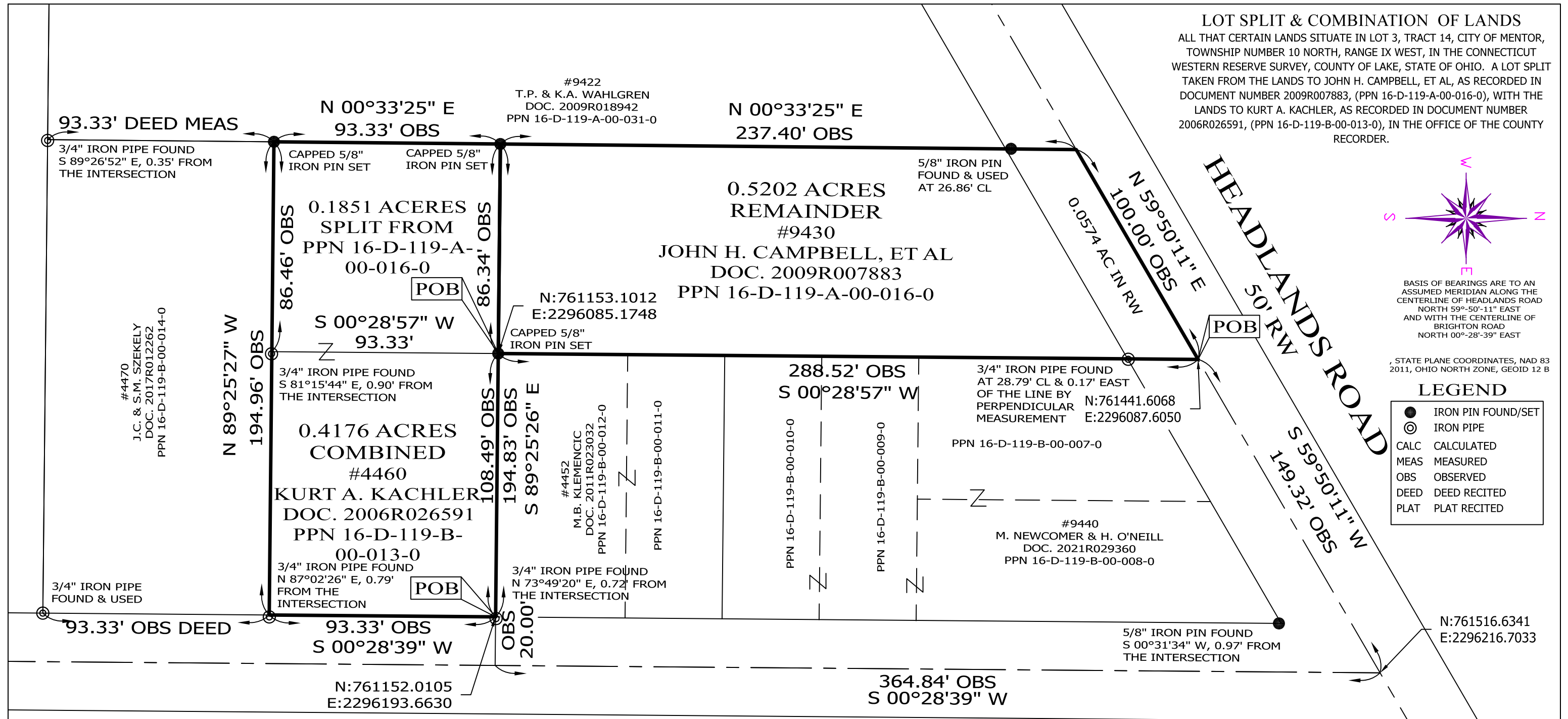

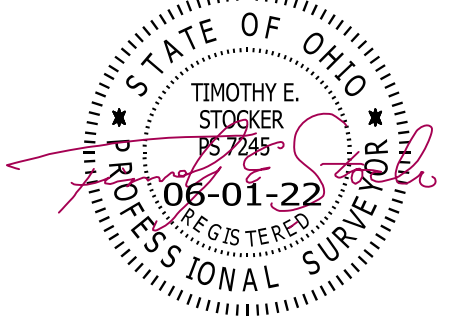
