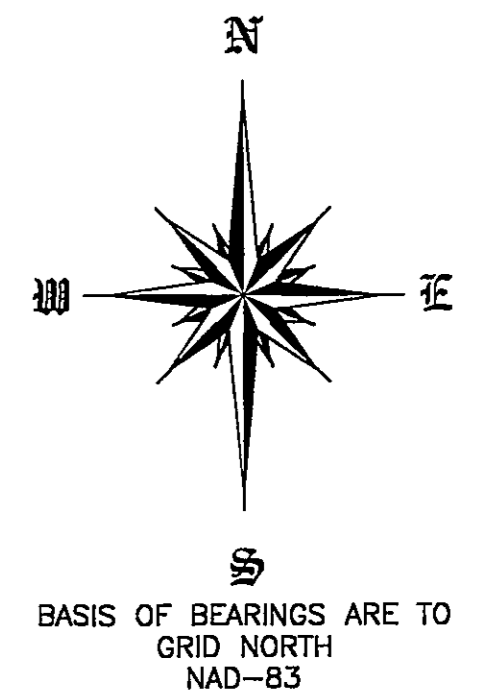
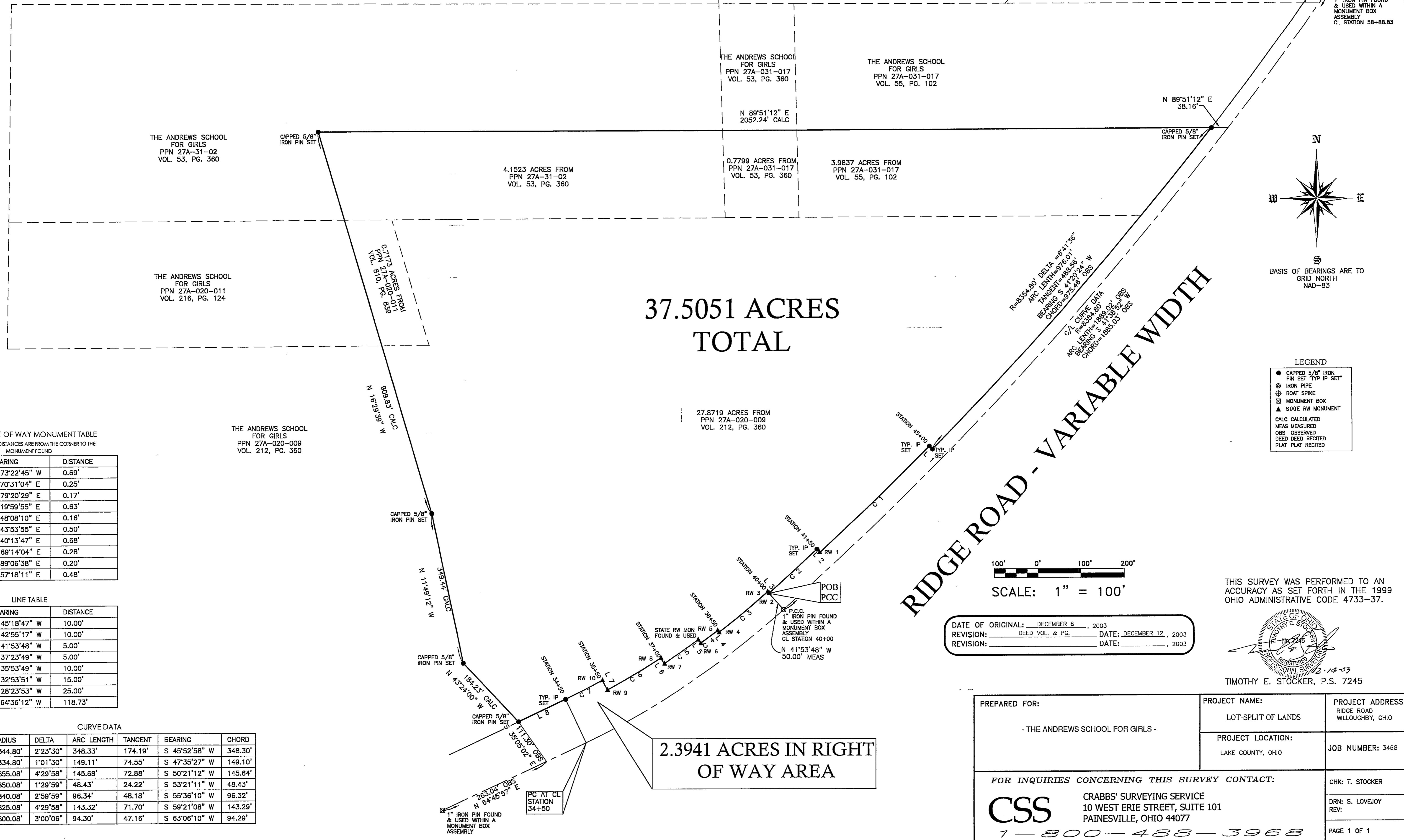


# LOT-SPLIT OF LANDS

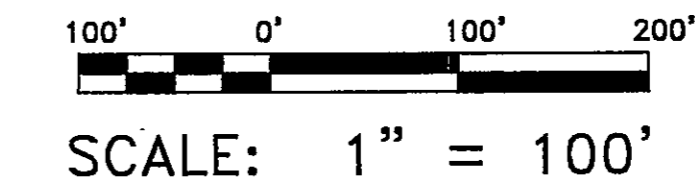

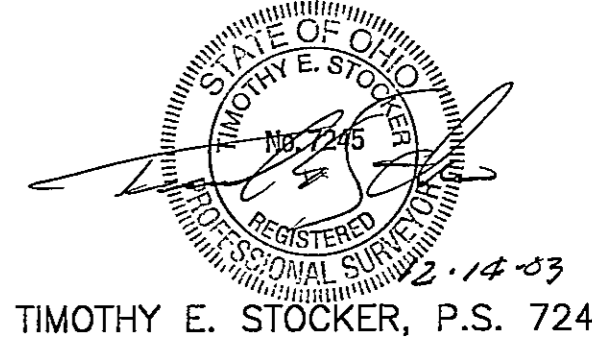
