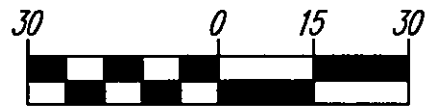

GRAPHIC SCALE

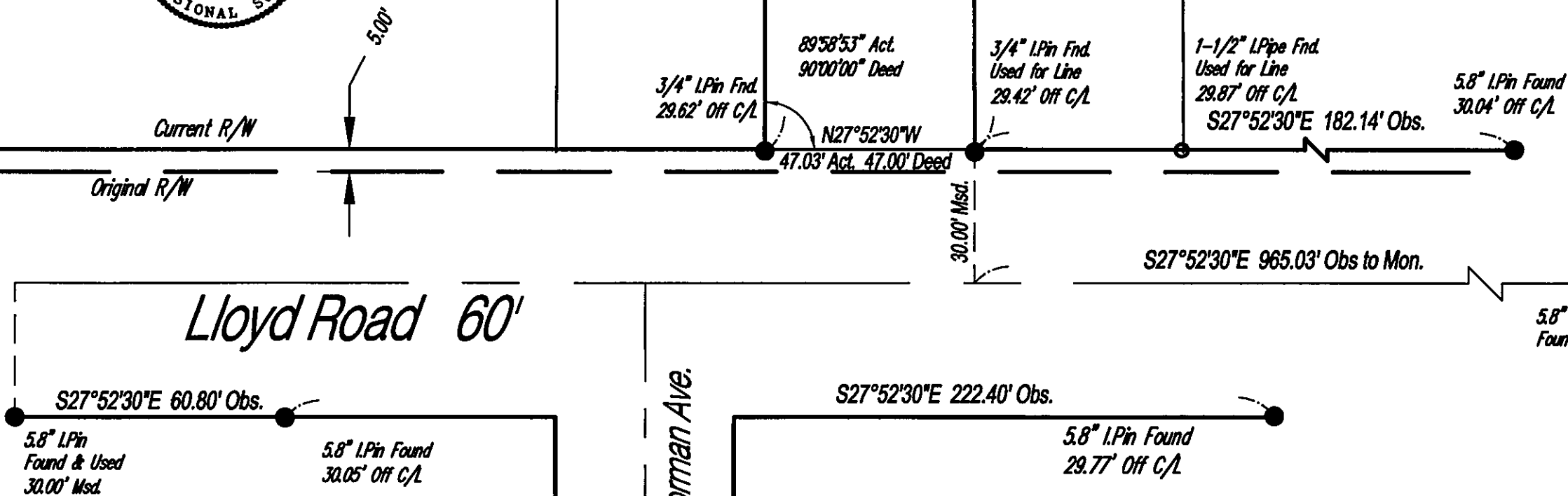
