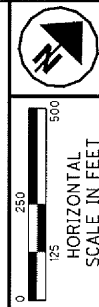

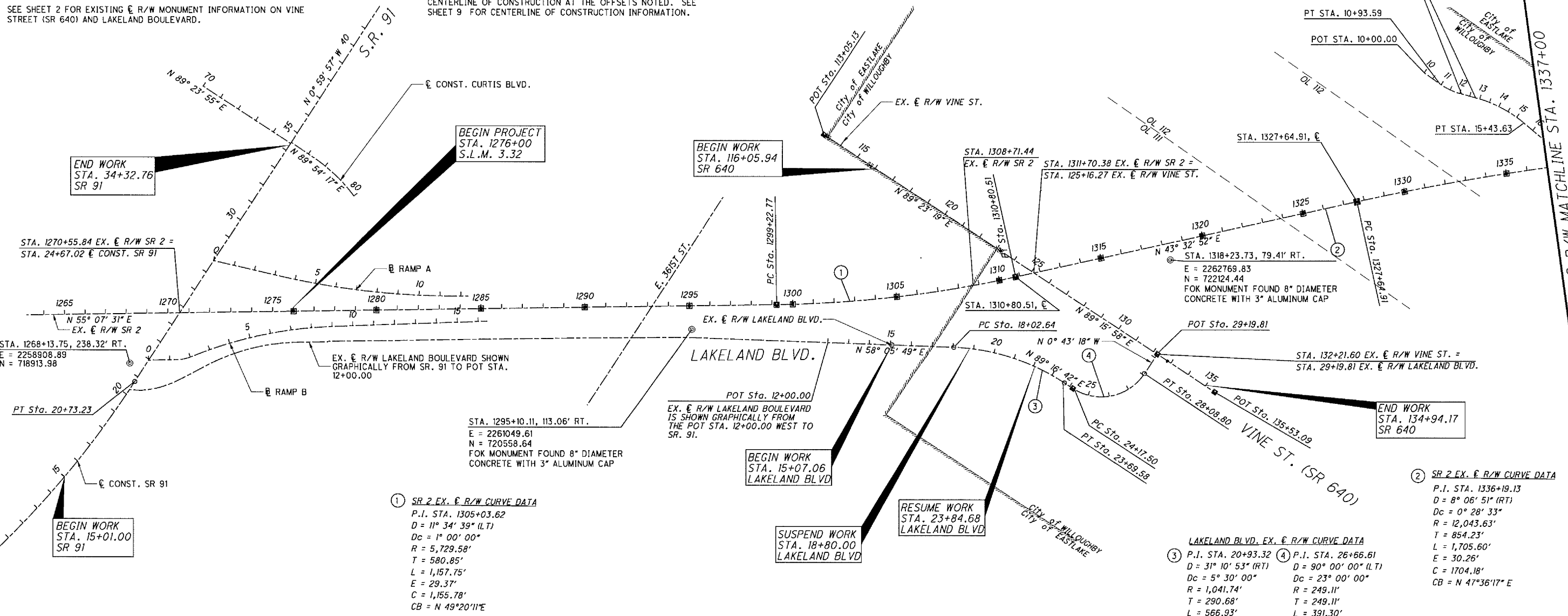

THE EX. E R/W ON SR 2, VINE STREET, LOST NATION ROAD AND REYNOLDS ROAD GENERALLY FOLLOWS THE PROPOSED E OF CONSTRUCTION. THE E OF CONSTRUCTION WILL BE INDEPENDENTLY REFERENCED ON THE CONSTRUCTION PLANS.

LOT LINES ARE GRAPHICALLY SHOWN FOR INFORMATIONAL PURPOSES. INTERSECTIONS OF LOT LINES AND STREETS ARE GRAPHICALLY SHOWN UNLESS A STATION AND BEARING IS GIVEN.

CENTERLINES OF CONSTRUCTION FOR SIDE ROADS AND BASELINES OF CONSTRUCTION FOR RAMP ARE GRAPHICALLY SHOWN FOR INFORMATIONAL PURPOSES. REFER TO THE CONSTRUCTION DRAWINGS FOR DETAILED GEOMETRIC DATA OF ALL SIDE ROAD CENTERLINES OF CONSTRUCTION AND RAMP BASELINES.

ALL RAMP B DATA SHOWN ARE PROP. B CONSTRUCTION. LIMITS OF R/W FOR SR 2 INCLUDING INTERCHANGE AREAS WERE SET BASED ON EX. E R/W SR 2. FOR VINE STREET RAMP B CONST. DATA SEE SHEET 2.

THE PROPOSED RIGHT OF WAY SHALL BE REFERENCED FROM THE CENTERLINE OF RIGHT OF WAY.

THE PLACING OF MONUMENTS SHALL BE UNDER THE DIRECTION OF A SURVEYOR REGISTERED IN THE STATE OF OHIO. THE CENTERLINE MONUMENT ASSEMBLY BOXES WILL BE INSTALLED BY THE HIGHWAY CONTRACTOR AT THE TIME OF CONSTRUCTION. THE IRON PIN WITH CAP MARKING THE ACTUAL CENTERLINE STATION POINT AND ANY REFERENCE MONUMENTS ARE TO BE SET BY THE RIGHT OF WAY DESIGN CONSULTANT.

CHANGES OR ALTERATIONS TO THE LOCATION OF ANY MONUMENTS SHOWN ON THIS PLAT REQUIRE PRIOR APPROVAL OF THE DISTRICT REAL ESTATE ADMINISTRATOR OF THE OHIO DEPARTMENT OF TRANSPORTATION. A REVISED CENTERLINE PLAT WITH THE NEW LOCATIONS SHALL BE RECORDED IN THE APPLICABLE COUNTY RECORDS AND THE OHIO DEPARTMENT OF TRANSPORTATION. SPECIFICATIONS FOR CENTERLINE MONUMENTS, REFERENCE MONUMENTS AND RIGHT OF WAY MONUMENTS ARE SHOWN ON STANDARD CONSTRUCTION DRAWING RM-1.1 OF THE OHIO DEPARTMENT OF TRANSPORTATION.
