GENERAL NOTES

SCOPE

THE WORK TO BE PERFORMED BY THE CONTRACTOR IN CONNECTION WITH THE TRAFFIC CONTROL DEVICES OF THIS PROJECT CONSIST OF FURNISHING LABOR, SUPPLIES, EQUIPMENT, MATERIALS AND PERFORMING ALL OPERATIONS NECESSARY FOR THE ACCEPTABLE INSTALLATION OF THE TRAFFIC CONTROL DEVICES, IN STRICT ACCORDANCE WITH THESE PLANS, NOTES AND SPECIFICATIONS. THESE NOTES, SCHEDULES AND DRAWINGS ARE INTENDED TO PROVIDE FOR ALL MATERIAL AND LABOR REQUIRED TO FURNISH AND INSTALL A COMPLETE TRAFFIC CONTROL SYSTEM.

UNDERGROUND UTILITIES

THE LOCATIONS OF THE UNDERGROUND UTILITIES AND OWNERS ARE SHOWN ON THE PLANS ARE AS OBTAINED FROM THE OWNERS OF THE UTILITY AS REQUIRED BY SECTION 153.64 OF THE OHIO REVISED CODE.

TRAFFIC CONTROL STANDARD CONSTRUCTION DRAWINGS

REFERENCES TO ITEM 608 100 mm CONCRETE WALK FOR CONTROLLER WORK PADS ON THE STANDARD CONSTRUCTION DRAWINGS IN THESE PLANS SHALL BE CONSIDERED TO READ AS REFERENCES TO ITEM 633 CONTROLLER WORK PAD.

REFERENCE TO SECTION 621, OR SUPPLEMENTAL SPECIFICATIONS 806, 847, 906 OR 947 ON THE STANDARD CONSTRUCTION DRAWINGS OR ELSEWHERE IN THESE PLANS SHALL BE CONSIDERED TO READ AS REFERENCES TO THE APPROPATE PORTIONS OF SECTIONS 641, 642, 643, 644, 645 AND 740.

PROGRESS SCHEDULE (CRITICAL PATH METHOD)

THE PRE-CONSTRUCTION MEETING SHALL BE HELD NO LATER THAN 30 DAYS AFTER THE CONTRACT IS SIGNED. THE CONTRACTOR SHALL SUBMIT THEIR PROPOSED CPM SCHEDULE AT THE PRE-CONSTRUCTION MEETING FOR REVIEW BY THE CONSTRUCTION ENGINEER. WRITTEN COMMENTS REGARDING THE CPM SCHEDULE WILL BE FORWARDED TO THE CONTRACTOR BY THE CONSTRUCTION ENGINEER WITHIN 14 CALENDAR DAYS AFTER THE PRE-CONSTRUCTION MEETING.

A FINAL CPM SCHEDULE SHALL BE SUBMITTED TO THE CONSTRUCTION ENGINEER WITHIN 30 CALENDAR DAYS FROM THE DATE OF THE PRE—CONSTRUCTION MEETING BUT AT LEAST SEVEN (7) CALENDAR DAYS PRIOR TO THE DATE DESIGNATED AS THE STARTING DATE IN THE CPM SCHEDULE. THE SCHEDULE SHALL BE SIGNED AND DATED BY THE PRIME CONTRACTOR AND NAMED SUB—CONTRACTORS.

ADJUSTMENTS IN CONTRACT TIME

TIME EXTENSIONS WILL ONLY BE CONSIDERED WHEN CONTROLLING ITEMS OF WORK ON THE APPROVED CPM SCHEDULE ARE AFFECTED DUE TO NO FAULT OF THE CONTRACTOR.

WHEN ADDITIONAL WORK IS REQUIRED, TIME EXTENSIONS WILL ONLY BE GRANTED FOR CONTROLLING ITEMS ON THE CPM SCHEDULE. TIME EXTENSIONS WILL ONLY BE GRANTED ON AN INTERSECTION BY INTERSECTION BASIS.

MAINTENANCE OF TRAFFIC SIGNAL INSTALLATIONS

THE CONTRACTOR SHALL BE RESPONSIBLE FOR MAINTAINING TRAFFIC SIGNAL AND/OR FLASHER INSTALLATIONS WITHIN THE PROJECT UNDER THE FOLLOWING CONDITIONS:

- A) EXISTING SIGNAL INSTALLATIONS WHICH THE PLANS REQUIRE THE CONTRACTOR TO ACTUALLY ADJUST, MODIFY OR OTHERWISE DISTURB: THE CONTRACTOR SHALL BE RESPONSIBLE FOR THE ENTIRE INSTALLATION (AT AN INTERSECTION) FROM THE TIME HIS OPERATION FIRST DISTURBS THE INSTALLATION UNTIL THE INSTALLATION HAS BEEN SUBSEQUENTLY REMOVED OR MODIFIED AND THE WORK IS ACCEPTED.
- B) NEW OR REUSED SIGNAL INSTALLATIONS OR DEVICES, INSTALLED BY THE CONTRACTOR: THE CONTRACTOR SHALL BE RESPONSIBLE FOR MAINTENANCE OF THESE FROM THE TIME OF INSTALLATION UNTIL THE WORK IS

THE CONTRACTOR SHALL CORRECT AS QUICKLY AS POSSIBLE ALL OUTAGES OR MALFUNCTIONS. HE SHALL PROVIDE THE MUNICIPALITY AND THE ENGINEER SUCH ADDRESSES AND PHONE NUMBERS WHERE HIS MAINTENANCE FORCES CAN BE CONTACTED THE CONTRACTOR SHALL PROVIDE ONE OR MORE PERSONS TO RECEIVE ALL CALLS AND DISPATCH THE NECESSARY MAINTENANCE FORCES TO CORRECT OUTAGES. SUCH A PERSON OR PERSONS MAY BE USED TO PERFORM OTHER DUTIES AS LONG AS PROMPT ATTENTION IS GIVEN TO THESE CALLS AND A PERSON IS READILY AVAILABLE CONTINUOUSLY 24 HOURS A DAY, 7 DAYS A WEEK. ALL LAMP OUTAGES, CABLE OUTAGES, ELECTRICAL FAILURES, EQUIPMENT MALFUNCTIONS AND MISALIGNED SIGNAL HEADS SHALL BE CORRECTED TO THE SATISFACTION OF THE ENGINEER WITH THE SIGNAL BACK TO SERVICE WITHIN FOUR HOURS AFTER THE CONTRACTOR HAS BEEN NOTIFIED OF THE OUTAGE OR MALFUNCTION.

IN THE EVENT NEW SIGNALS ARE DAMAGED PRIOR TO ACCEPTANCE, ALL DAMAGED EQUIPMENT, EXCEPT POLES AND CONTROL EQUIPMENT, SHALL BE REPLACED BY THE CONTRACTOR TO THE SATISFACTION OF THE ENGINEER WITH THE SIGNAL BACK IN SERVICE WITHIN EIGHT (8) HOURS AFTER THE CONTRACTOR HAS BEEN NOTIFIED OF THE DAMAGE.

IF POLES AND/OR CONTROL EQUIPMENT ARE DAMAGED AND MUST BE REPLACED, THE CONTRACTOR SHALL MAKE TEMPORARY REPAIRS AS NECESSARY TO BRING THE SIGNAL BACK INTO FULL OPERATION WITHIN THE ALLOWED EIGHT (8) HOUR PERIOD, AND SHALL MAKE PERMANENT REPAIRS OR REPLACEMENT AS SOON THEREAFTER AS POSSIBLE.

NONE OF THE ABOVE SHALL BE CONSTRUED AS COLLECTIVE OR CONSECUTIVE OUTAGE TIME PERIODS AT ANY ONE LOCATION. THAT IS, WHERE MORE THAN ONE OUTAGE OCCURS AT ANY ONE LOCATION, THEN THE ALLOTTED TIME LIMIT SHALL BE FOR THE WORST SINGLE OUTAGE OR MALFUNCTION.

WHERE OUTAGES ARE THE DIRECT RESULT OF A VEHICLE ACCIDENT, THE RESPONSE OF THE CONTRACTOR SHALL BE AS OUTLINED ABOVE. THE CONTRACTOR SHALL BE RESPONSIBLE FOR COLLECTION OF ANY COMPENSATION FOR THIS WORK FROM THOSE PARTIES RESPONSIBLE FOR THE DAMAGE.

WHERE THE CONTRACTOR HAS FAILED TO OR CANNOT RESPOND TO AN OUTAGE OR SIGNAL EQUIPMENT MALFUNCTION, AT THESE LOCATIONS WITHIN HIS RESPONSIBILITY, THE ENGINEER MAY INVOKE THE PROVISIONS OF SECTION 105.15 AND ANY SUBSEQUENT BILLINGS TO THE STATE OR THE CITY OF PAINESVILLE FOR POLICE SERVICES AND MAINTENANCE SERVICE BY CITY FORCES OR OUTSIDE CONTRACTORS HIRED BY THE STATE OR CITY, SHALL BE DEDUCTED FROM MONIES DUE OR TO BECOME DUE THE CONTRACTOR IN ACCORDANCE WITH PROVISIONS OF SECTION 105.15.

THE CONTRACTOR SHALL PROVIDE THE MAINTENANCE SERVICE ENTIRELY WITH HIS FORCES.

THE CONTRACTOR SHALL BE RESPONSIBLE FOR ANY DAMAGE TO ANY TRAFFIC SIGNAL COMPONENTS REQUIRED TO BE HANDLED DURING THE RELOCATION OF POLES AND REVISIONS TO THE SIGNAL SYSTEM.

WHEN A TRAFFIC SIGNAL MUST BE TAKEN OUT OF SERVICE BY THE CONTRACTOR, DUE TO CONSTRUCTION PROCEDURES, THIS OUTAGE SHALL NOT EXCEED 3 HOURS AND SHALL NOT INCLUDE THE HOURS OF 7:00 AM TO 9:00 AM, 12:00 NOON TO 1:00 PM AND/OR 4:00 PM TO 7:00 PM.

THE FOLLOWING INTERSECTIONS, WHEN THE SIGNAL IS OUT OF SERVICE DUE TO CONSTRUCTION PROCEDURES, OR DUE TO AN OUTAGE OR EQUIPMENT MALFUNCTION AS DESCRIBED ABOVE, SHALL BE PROTECTED BY THE CONTRACTOR, BY THE INSTALLATION OF TEMPORARY "STOP" SIGNS, EXCEPT FOR THE FOLLOWING INTERSECTIONS, WHEN THE SIGNAL IS OUT OF SERVICE DUE TO CONSTRUCTION PROCEDURES, OR DUE TO AN OUTAGE OR EQUIPMENT MALFUNCTION AS DESCRIBED ABOVE, SHALL BE PROTECTED BY OFF-DUTY CITY OF PAINESVILLE POLICE OFFICERS, HIRED BY THE CONTRACTOR:

- 1. MENTOR AVENUE (US 20) & ERIE STREET/WATSON STREET/WOOD STREET
- 2. ERIE STREET (US 20) & LIBERTY STREET/RICHMOND STREET
- 3. ERIE STREET (US 20) & ST. CLAIR STREET 4. ERIE STREET (US 20) & STATE STREET
- 5. LIBERTY STREET & MENTOR AVENUE/N. PARK STREET
- 6. JACKSON STREET & FERN STREET/SR 44 SOUTHBOUND OFF RAMP
- 7. RICHMOND STREET & SR 2 EASTBOUND OFF RAMP 8. STATE STREET & CHESTER STREET/STORRS STREET

ANY VEHICULAR TRAFFIC SIGNAL HEAD, EITHER NEW OR EXISTING WHICH WILL BE OUT OF OPERATION SHALL BE COVERED IN THE MANNER DESCRIBED IN 632.24.

ALL COSTS RESULTING IN THE ABOVE REQUIREMENTS SHALL BE CONSIDERED TO BE INCLUDED IN THE LUMP SUM PRICE BID FOR ITEM 614, MAINTAINING TRAFFIC.

MAINTENANCE OF TRAFFIC

THIS ITEM SHALL CONSIST OF MAINTENANCE OF TRAFFIC ON EXISTING ROADWAYS IN ACCORDANCE WITH THE OHIO MANUAL OF UNIFORM TRAFFIC CONTROL DEVICES FOR STREETS AND HIGHWAYS, CURRENT EDITION, LATEST REVISION.

ALL TRAFFIC CONTROL DEVICES REQUIRED INSIDE THE WORK LIMITS SHALL BE FURNISHED, ERECTED, MAINTAINED AND SUBSEQUENTLY REMOVED BY THE CONTRACTOR.

THE CONTRACTOR SHALL MAINTAIN TRAFFIC AT ALL TIMES IN ACCORDANCE WITH THE REQUIREMENTS OF ITEM 614. TWO WAY TRAFFIC SHALL BE MAINTAINED AT ALL TIMES

PROCEDURES FOR MAINTAINING TRAFFIC SHALL BE IN ACCORDANCE WITH THE OHIO MANUAL OF UNIFORM TRAFFIC CONTROL DEVICES AND STANDARD CONSTRUCTION DRAWING MT-95.30M. WORK ON OR BEYOND THE SHOULDER SHALL BE IN ACCORDANCE WITH PLATES C-11 THROUGH C-13. MINIMUM LANE WIDTHS DURING MAINTENANCE OF TRAFFIC SHALL BE 3.4 METERS. A MINIMUM OF ONE LANE PER DIRECTION SHALL BE MAINTAINED AT ALL TIMES.

ALL ADVANCE WARNING SIGNS FOR ANY CONDITION WHICH RESTRICTS TRAFFIC SHALL BE ERECTED BEFORE ANY SUCH RESTRICTION IS PUT INTO EFFECT. ALL SUCH SIGNS SHALL BE COVERED OR REMOVED FROM VIEW OF TRAFFIC WHEN THEY ARE NOT APPLICABLE. AS DETERMINED BY THE ENGINEER.

IF THE CONTRACTOR FAILS TO COMPLY WITH THE PROVISIONS FOR TRAFFIC CONTROL AS SET FORTH IN THESE PLANS OR WITH PROVISIONS OF THE OMUTCD, AND SUCH FAILURE RESULTS IN A CONDITION AT THE WORK SITE WHICH IS UNSAFE FOR TRAFFIC, THE ENGINEER SHALL SUSPEND WORK UNTIL THE CONTRACTOR COMPLIES WITH THE NECESSARY REQUIREMENTS.

THE CONTRACTOR MAY CLOSE APPROACHES AT THE INTERSECTION FOR A PERIOD NOT TO EXCEED 10 MINUTES FOR THE PURPOSE OF ERECTING SIGNAL SUPPORTS BY THE USE OF OFF DUTY POLICE OFFICER(S) WITH PATROL CAR(S). CLOSURES SHALL ONLY BE PERMITTED BETWEEN THE HOURS OF 10:00 AM AND 3:00 PM.

IF IT IS NECESSARY TO STOP ALL TRAFFIC FOR THE ERECTION OF SIGNAL SUPPORTS, THE WORK SHALL BE SO ARRANGED THAT THE STOPPAGE IS LESS THAN TEN (10) MINUTES IN ANY ONE (1) THIRTY (30) MINUTE PERIOD. NO STOPPAGE OF TRAFFIC SHALL OCCUR FOR THE ERECTION OF OVERHEAD SUPPORTS, CUTTING AND INSTALLING LOOP DETECTOR WIRE OR HANGING SPAN WIRE AND SIGNAL HEADS WITHOUT A LAW ENFORCEMENT OFFICER WITH PATROL CAR AT THE SITE FOR ASSISTANCE IN CONTROLLING TRAFFIC. IT SHALL BE THE CONTRACTOR'S RESPONSIBILITY TO PROVIDE THE SERVICES AND SCHEDULING OF SAID LAW ENFORCEMENT OFFICER WITH PATROL CAR. COST OF ALL THE ABOVE SHALL BE INCLUDED IN THE LUMP SUM BID FOR ITEM 614, MAINTAINING TRAFFIC.
