# EQUIPMENT AND MATERIAL STORAGE

IN ORDER TO PROVIDE FOR THE SAFETY OF THE TRAVELING PUBLIC, THE CONTRACTORS ATTENTION IS DIRECTED TO 614.03. IN ADDITION THE FOLLOWING PROVISIONS SHALL APPLY:

- 1) ANY REMOVED ITEMS SHALL NOT BE STORED ON THE RIGHT OF WAY FOR MORE THAN THIRTY DAYS.
- 2) THE STORAGE OF EQUIPMENT, MATERIALS AND VEHICLES WITHIN THE HIGHWAY RIGHT OF WAY WILL BE PERMITTED. THE NUMBER OF AREAS AND EXACT LOCATIONS SHALL BE APPROVED BY THE ENGINEER.
- 3) ALL DISTURBED AREAS SHALL BE RETURNED TO THEIR ORIGINAL CONDITION AT NO EXPENSE TO THE STATE.

# CONSTRUCTION NOISE

ACTIVITIES AND LAND USE ADJACENT TO THIS PROJECT MAY BE AFFECTED BY CONSTRUCTION NOISE. IN ORDER TO MINIMIZE ANY ADVERSE CONSTRUCTION NOISE IMPACTS, ANY POWER-OPERATED CONSTRUCTION-TYPE DEVICE SHALL NOT BE OPERATED BETWEEN THE HOURS OF 10 PM AND 6 AM. IN ADDITION, ANY SUCH DEVICE SHALL NOT BE OPERATED AT ANY TIME IN SUCH A MANNER THAT THE NOISE CREATED SUBSTANTIALLY EXCEEDS THE NOISE CUSTOMARILY AND NECESSARILY ATTENDANT TO THE REASONABLE AND EFFICIENT PERFORMANCE OF SUCH EQUIPMENT.

GENERAL NOTES

THIS ITEM SHALL CONSIST OF FURNISHING AND INSTALLING AN ET-2000, OPTION "C" GUARDRAIL END TERMINAL AS MANUFACTURED BY SYRO STEEL COMPANY, 1170 N. STATE STREET, GIRARD, OHIO 44420 (TELEPHONE: 216-545-4373)

THE ANCHOR ASSEMBLY SHALL BE PLACED IN ACCORDANCE WITH THE MANUFACTURER'S CURRENT SPECIFICATIONS AND AT THE LOCATIONS SHOWN IN THE PLANS.

PAYMENT FOR THE ABOVE WORK SHALL BE MADE AT THE CONTRACT PRICE FOR 606, EACH, ANCHOR ASSEMBLY, TYPE E. PAYMENT SHALL INCLUDE ALL LABOR, TOOLS, EQUIPMENT AND MATERIALS NECESSARY TO CONSTRUCT THE 25' LONG ANCHOR ASSEMBLY, INCLUDING ALL RALATED HARDWARE, NOT SEPARATELY SPECIFIED, AS REQUIRED BY THE MANUFACTURER TO INSTALL A COMPLETE AND FUNCTIONAL ANCHOR ASSEMBLY. THIS ITEM SHALL ALSO INCLUDE PAYMENT OVER AND ABOVE THE COST OF STANDARD TYPE 5 GUARDRAIL FOR INSTALLING TYPE 1 BREAKAWAY POSTS PER STANDARD CONSTRUCTION DRAWING GR-1.3 AT THE FOLLOWING LOCATIONS:

1) AT THE POINT WHERE THE ANCHOR ASSEMBLY AND THE GUARDRAIL RUN MEET; AND 2) AT THE NEXT THREE (3) POST LOCATIONS INTO THE GUARDRAIL RUN.

# EXCAVATION NOT INCLUDING EMBANKMENT CONSTRUCTION, AS PER PLAN

# DITCH CLEANOUT

THIS WORK SHALL CONSIST OF RE-ESTABLISHING THE CROSS-SECTION OF AN EXISTING DITCH. SURPLUS OR UNSUITABLE MATERIAL, AS DETERMINED BY THE ENGINEER, SHALL BE DISPOSED OF AS PER 203.05. EMBANKMENT REQUIRED FOR ERODED CONDITIONS SHALL MEET THE REQUIREMENTS OF 203.07 EXCEPT THAT THE COMPACTION REQUIREMENTS ARE WAIVED.

THE LOCATIONS OF THIS WORK SHALL BE AS DIRECTED BY THE ENGINEER. PAYMENT FOR ITEM 203 — EXCAVATION NOT INCLUDING EMBANKMENT CONSTRUCTION, SHALL INCLUDE ALL COSTS OF REMOVAL, DISPOSAL AND RESTORATION WITH SEEDING AND MULCHING, FERTILIZING AND LIMING. MEASUREMENT WILL BE BY LOOSE VOLUME IN CARRIER. THE FOLLOWING ESTIMATED QUANTITY HAS BEEN INCLUDED IN THE GENERAL SUMMARY TO BE UTILIZED AS OUTLINED ABOVE, AS DIRECTED BY THE ENGINEER.

## ITEM 203 - LINEAR GRADING

THIS ITEM SHALL CONSIST OF EXCAVATING TOPSOIL, PLACING GRANULAR MATERIAL AND APPLYING HERBICIDE AS SPECIFIED IN THE PLANS AND IN ACCORDANCE WITH THE FOLLOWING:

ALL COLLECTED DEBRIS AND TOPSOIL, INCLUDING RHIZOMES, ROOTS AND OTHER VEGETATIVE PLANT MATERIAL SHALL BE REMOVED AND DISPOSED OF AS SPECIFIED IN SECTION 203.05 OF THE CONSTRUCTION AND MATERIAL SPECIFICATIONS.

ANY REMOVAL OF THE ABOVE ITEMS WHICH EXTEND BELOW THE PROPOSED SUBGRADE SHALL BE REPLACED WITH COMPACTABLE GRANULAR MATERIAL CONFORMING TO 203.02 AND SHALL BE PLACED TO GRADE AS DETAILED ON THE TYPICAL SECTION OR AS APPROVED BY THE ENGINEER.

HERBICIDE SHALL BE TREFLAN E.C., SPIKE OR AN APPROVED EQUAL AND SHALL BE APPLIED TO THE PREPARED AREA AFTER FINAL LEVELING AND GRADING HAS BEEN COMPLETED. THE APPLICATION SHALL BE JUST PRIOR TO PAVING AND SHALL STRICTLY ADHERE TO THE MANUFACTURER'S LABEL INSTRUCTION.

ONLY PROPERLY LICENSED PERSONNEL SHALL APPLY HERBICIDES AS REQUIRED BY THE OHIO REVISED CODE.

ALL EQUIPMENT, MATERIAL AND LABOR REQUIRED TO PERFORM THE WORK OUTLINED ABOVE SHALL BE INCLUDED FOR PAYMENT UNDER ITEM 203, LINEAR GRADING.

# ITEM 448, ASPHALT CONCRETE INTERMEDIATE COURSE, TYPE I (UNDER GUARDRAIL), AS PER PLAN

THIS ITEM SHALL CONSIST OF PAVING UNDER GUARDRAIL AS SPECIFIED IN THE PLANS AND IN ACCORDANCE WITH THE FOLLOWING:

PAVING SHALL CONSIST OF PLACING ITEM 448 TO THE DEPTH SPECIFIED USING ONE OF THE FOLLOWING METHODS:

METHOD A: 1) SET GUARDRAIL POSTS

2) PLACE ITEM 448

METHOD B: 1) PLACE ITEM 448

2) BORE ASPHALT AT POST LOCATIONS (SEE NOTE 1)

3) SET GUARDRAIL POSTS

4) PATCH AROUND POSTS (SEE NOTE 2)

NOTE 1: BORING OF ASPHALT MAY BE EXCLUDED IF STEEL POSTS ARE TO BE USED.

NOTE 2: THE MATERIAL USED FOR PATCHING SHALL BE A BITUMINOUS CONCRETE APPROVED BY THE ENGINEER. PATCHING AREAS SHALL BE COMPACTED USING EITHER HAND OR MECHANICAL METHODS. FINISHED SURFACES SHALL BE SMOOTH AND SLOPED TO DRAIN AWAY FROM THE POSTS.

ALTERNATE METHODS MAY BE USED WITH PRIOR APPROVAL OF THE ENGINEER. ALL EQUIPMENT, MATERIALS AND LABOR REQUIRED TO PERFORM THE WORK OUTLINED ABOVE, WITH THE EXCEPTION OF SETTING GUARDRAIL POSTS SHALL BE INCLUDED FOR PAYMENT UNDER ITEM 448 ASPHALT CONCRETE INTERMEDIATE COURSE, TYPE I (UNDER GUARDRAIL), AS PER PLAN.

#### ITEM 202, RAISED PAVEMENT MARKERS REMOVED FOR STORAGE

#### ITEM 203, EMBANKMENT, AS PER PLAN

THE TOP 3 INCHES OF EXPOSED EMBANKMENT SHALL CONSIST OF LOOSE, FRIABLE, LOAMY SOIL WITHOUT THE ADMIXTURE OF REFUSE OR STONE GREATER THAN ONE (1) INCH. THE SOIL SHALL BE CAPABLE OF SUPPORTING VEGETATION.
