 Surveyors Report

To the Honorable Board of Commissioners of Lake County "Greening"
 The undersigned in obedience to your order dated June 6th 1898 proceeded on the 6th day of July 1898 to survey & mark the proposed County Road described in said order under the directions of the crews therein named and respectfully submit the following return of said survey.
 Beginning in the center of the Lloyd Road at the present terminal of the St Clair Road Thence N 58 1/2° E 28 chains & 16 links through lands owned by the Community of Shakers. Wm Lloyd & Fred Linden to a point in the E line of said Lindens land where we drove a gas pipe stake Thence N 55° E 18 chains & 19 links to the west line of lands owned by Henry Hensch & Donald Gafarnard & through lands owned by W. A. Mc Elrath & Wm Lloyd where we drove a gas pipe stake. Thence N 58 1/2° E 20 chains & forty links and along the line dividing the lands of said Hensch & Gafarnard to the center of stump town road so called & at a gas pipe stake. Thence N 31 1/2° W 30 feet along the angle of said road to a gas pipe stake in the center of said road & on the line dividing lands owned or controlled by Mrs. Sabet & Frank Decille Thence N 57 1/2° E and along the above described property lines 36 chains & 39 links to the west line of land owned by C. W. Reed & to a gas pipe stake driven in said line. Thence N 68° E 23 chains and 65 links & through lands owned by C. W. Reed to a gas pipe stake driven in the center of Rush Road. for more minute particulars see annexed plat of the above survey which I hereby certify to be correct.
